

SUMMARY ANNUAL REPORT

For EdVisions Cooperative Benefit Plan

This is a summary of the annual report of the EdVisions Cooperative Benefit Plan, EIN 41-1812791, Plan No. 501, for the period July 01, 2018 through June 30, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

EdVisions Cooperative has committed itself to pay certain self-funded dental claims incurred under the terms of the plan, which were administered on behalf of the plan by DDMN ASO, LLC.

Insurance Information

The plan has contracts with Blue Cross Blue Shield of Minnesota, EyeMed Vision Care, The Lincoln National Life Insurance Company and Standard Insurance Company to pay health, vision, life insurance, temporary disability, long-term disability, prescription drug and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2019 were \$2,068,406.
